



Description: ON YOUR VEHICLE, IT MAY BE POSSIBLE THAT THE REAR SHOCK ABSORBERS MAY EXPERIENCE CORROSION BETWEEN THE EXTERNAL RESERVOIR MOUNTING FLANGE AND THE DAMPER BODY, RESULTING IN POSSIBLE SEPARATION OF THE EXTERNAL RESERVOIR. CUSTOMERS MAY EXPERIENCE A BOUNCY RIDE, NOISE, OR LEAKING FLUID NEAR THE REAR WHEELS PRIOR TO THE DETACHMENT OF AN EXTERNAL RESERVOIR.

IF A REAR SHOCK ABSORBER EXTERNAL RESERVOIR SEPARATES FROM THE VEHICLE, IT CAN CREATE A POTENTIAL ROAD HAZARD FOR OTHER ROAD USERS, INCREASING THE RISK OF A CRASH.

CARFAX Glossary

CARFAX Well Maintained - Regular Oil Changes
